AFFIDAVIT

- 1) I make this Affidavit in support of my Application of the 22nd day of September, 2011,
requesting Planning Permission in relation to land at Cadastre Reference Number
A20108B000.
- 2) I seek leave to refer to my Application for leave to apply for Judicial Review of the
Respondents decision referred to in paragraph 4 hereof.
- 3) On the 11th day of June, 2012, I wrote to the Respondent requesting Discovery of all
documents in the possession or power of the Minister for the Environment. A copy of the
said letter is now shown to me, marked 'JBd'AC 1' and exhibited hereto.
- 4) On the 31st day of August, 2012, I received from the Director of Planning Control Services a
letter permitting a file search in relation to the said parcel of land requesting me to contact
the Search Officer as stated therein. A copy of the said letter is now shown to me, marked
'JBd'AC 2' and exhibited hereto.

- 5) When I attended the Environment Department at or about 12:15pm on the 31st August, 2012, the aforesaid Search Officer declined to allow me to inspect any applications other than those exclusively relating to my said parcel of land, notwithstanding that they included my said parcel of land at Cadastre Reference Number A20108B000.

- 6) Accordingly I apply to this Honourable Court judicially for leave to seek a Review of the decision referred to in the last preceding paragraph and to make such order as may seem just.
